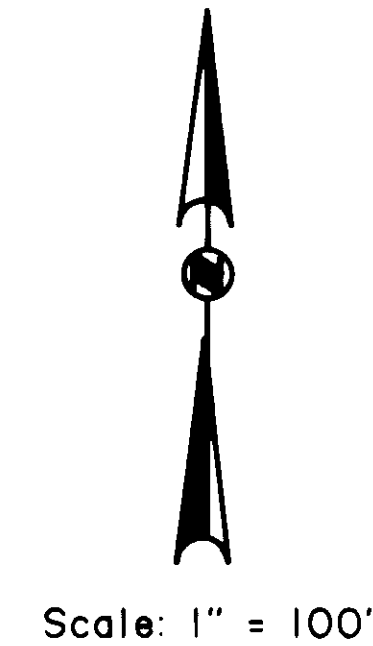
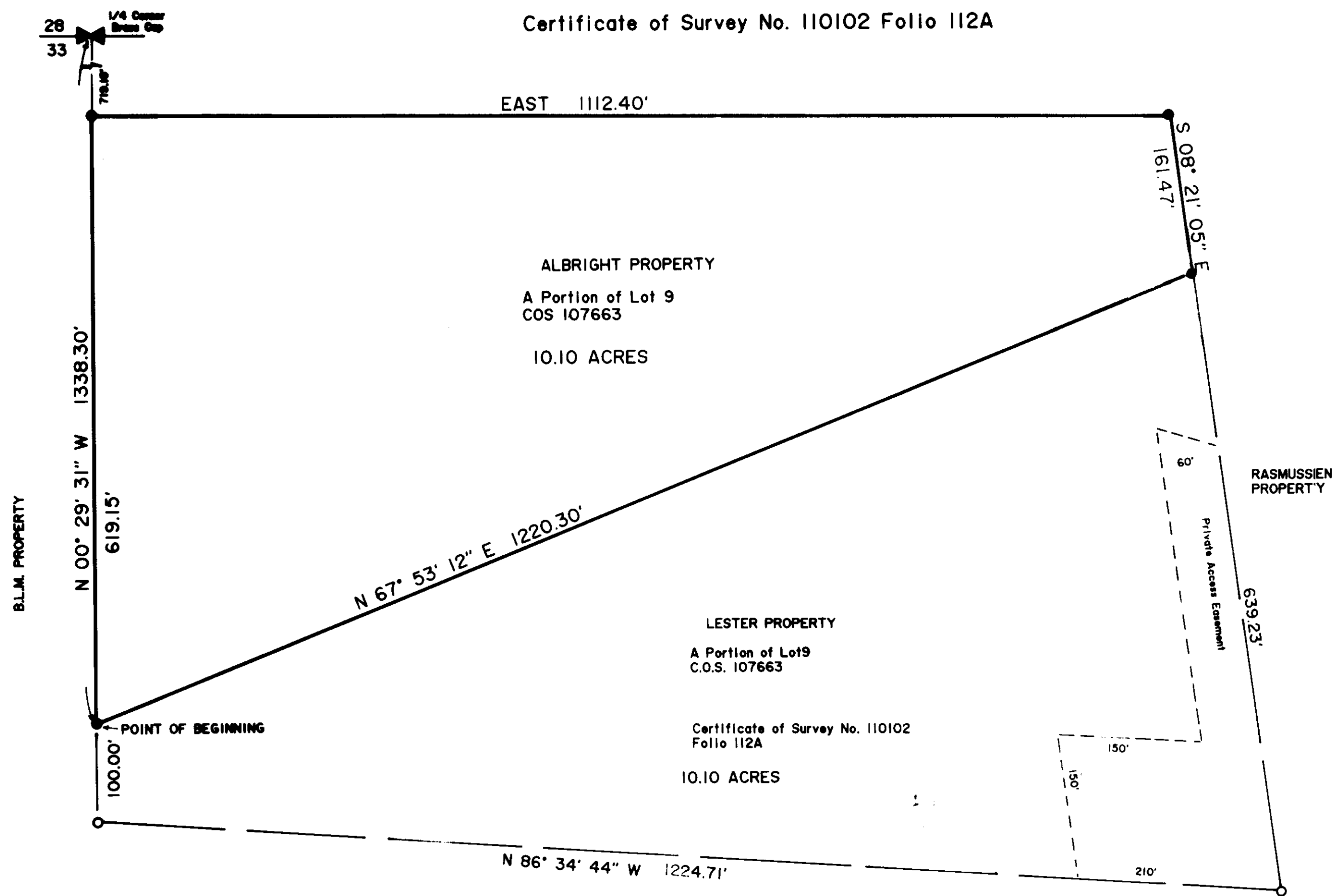

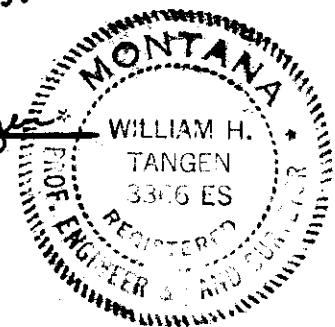

PROPERTY DESCRIPTION

That portion of Lot 9 of Recorded Certificate of Survey No. 107663, recorded on March 25, 1977 in Jefferson County, Montana, and being that portion of Lot 9 shown on Certificate of Survey No. 110102 Folio 112A but not described thereon, being described in the Northeast 1/4 of Section 33, Township 9 North, Range 3 West, P.M.M., Jefferson County, Montana, and more particularly by metes and bounds as follows:

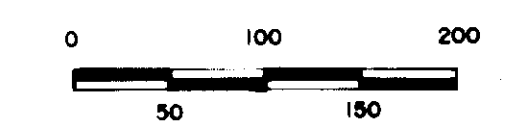
Commencing at the True Point of Beginning, from which the North 1/4 corner of Section 33 bears N 00° 29' 31" W a distance of 1338.30 feet; thence N 00° 29' 31" W a distance of 619.15 feet to a point, said point being the northwest corner of the original Lot 9; thence EAST a distance of 1112.40 feet to a point, said point being the northeast corner of the original Lot 9; thence S 08° 21' 05" E a distance of 161.47 feet to a point; thence S 67° 53' 12" W a distance of 1220.30 feet to the Point of Beginning.
