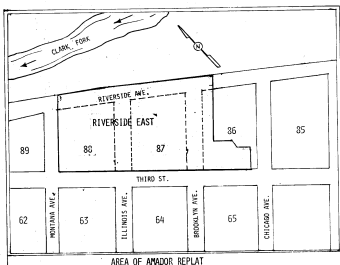
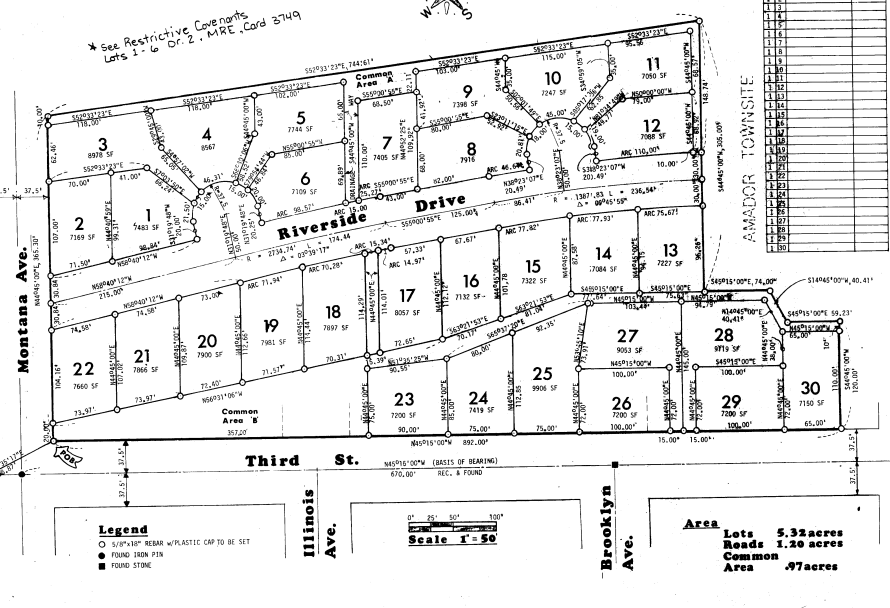


RIVERSIDE EAST
